Generalized Treatment Decision Tree

Napa County Mosquito Abatement District

A phased approach is used when managing vector populations. The management alternative and material selected by District personnel is that which will be the most effective, has the least environmental impact, and works best with the conditions encountered. In general the progression of choices is as follows: physical control (nonchemical such as ditching, plant trimming, dumping of containers), biological control (e.g., *Bacillus sphaericus*, fish), chemical control larvicides (e.g., Bti, methoprene, spinosad), surfactants (e.g., BVA-2 Oil, Coco Bear Oil), vegetation management (herbicides), and chemical control (adulticides).

Generalized Treatment Decision Tree


1. Inspection, location, and identification of vector(s)
2. Determination of life stages present and density of population by life stage made based on observation and/or samples collected
3. Size of area with vectors determined based on sampling
4. Assess proximity of residential, business, and recreational areas to vector breeding site
5. Assess weather conditions to determine emergence of adult vectors, potential spread/activity of adult vectors, risk of significant human/vector interactions, and vector management methods that can be effectively used
6. Consult equipment, treatment, and pesticide use guideline tables
7. Use least toxic materials, least impactful, and most effective methodology to manage vector population to healthful level whenever possible (within limitations of biotic and abiotic conditions at the time)

Factors that influence material, equipment and technique utilized to manage vector populations include but are not limited to:

- number of sites simultaneously breeding vectors
- predominant life stage(s) of vector(s) found at breeding site
- species of vector(s) found at a given location
- size of the site producing vector organisms
- site access
- safety issues (e.g. cracked ground, wet levees, proximity of sensitive receptors)
- potential for impact to site and/or to nontarget organisms
- weather conditions (e.g. wind , rain, air temp, water temp)
- staff and equipment available
- material (pesticide) availability
- density of vegetative cover
- frequency of production of vectors
- water quality (e.g. pH, DO, organic content, salinity)
- permits

The decision on where and when to treat vector populations is based on thresholds. These thresholds are only guidelines since each site is different and there are many abiotic and biotic factors that can affect tolerable vector population levels.

Mosquitofish Stocking Policy

Mosquitofish Stocking Policy

In an effort to minimize unwanted environmental impacts mosquitofish are not placed in sources known or thought to be habitats for endangered, threatened or rare species, or that may connect to or lead to waters of the U.S. or the State of California. Care must be taken when introducing mosquitofish into sources where they can migrate to habitats used by endangered, threatened or rare species. Mosquitofish can still be used in ornamental fish ponds, water gardens and abandoned swimming pools in urban and suburban areas without worrying about endangered species conflicts.

It is against California Department of Fish and Game regulations for private citizens to plant mosquitofish in waters of the State without a permit (Title 14 CCR, Fish and Game Code, Sections 1.63, 238.5 and 6400).

Mosquitofish provided by Napa County Mosquito Abatement District are intended for mosquito control purposes only. Exclusive of homeowner backyard water gardens and ornamental ponds, mosquitofish should not be introduced in potential mosquito breeding sources by anyone other than certified mosquito control technicians or California Fish and Wildlife personnel.

Aerial Treatment Guidelines

AERIAL TREATMENT GUIDELINES

Aerial control measures to control immature mosquitoes may be instituted when one or more of the following conditions exist:

The area to be treated is inaccessible by conventional ground control methods and fits District treatment guidelines

OR

The acreage and conditions are excessive and/or extreme enough to be cost effective to treat by air and fits District treatment guidelines

OR

An urgent situation exists where timing is critical or the number of support vehicles are limited because of the number of existing jobs

All aerial treatments must be approved and ordered by a supervisor.

If conditions fit the Aerial Treatment Guidelines, the operator must supply the supervisor with the following:

1. Map coordinates.
2. Source number(s) if available.
3. Physical map of target area for pilot, including:
 - a. Date of request.
 - b. Maximum number of days pilot has to effectively treat the larval population
 - c. Material to be used.
 - d. Rate of application.
 - e. Acreage to be treated drawn in and highlighted or marked with a highlighter.
4. Written description of location of source.
