## MANAGER'S REPORT

- -The District completed 15 service calls.
- -District manager reviewed Assembly Bill 1788 which limits rodenticide availability and use; updates to follow.
- -Wes Maffei, District Manager, and Karl Malud-Roam of Vector Control Consultants, continues to work on "white paper" for mosquito control and have amassed over 3500 references.
- -The district manager is currently working with Clarke to create an Aedes *aegypti* awareness program which includes but is not limited to presentations, brochures, public service announcements and doorhangers.
- -The district manager will be attending the AMCA conference in March 2020 to be held in Oregon.
