District Manager noted updates to the current reserve policy adding Pension Liability and Wetlands Management funds; the authority for the District Manager to transfer undesignated funds held with the County to the newly created funds, achieving a target balance for said funds, and language to include Public Agency Retirement Services (PARS) as a holder of District funds.

REVIEW AND TAKE ACTION ON SERVICES AGREEMENT WITH VECTOR CONTROL CONSULTANTS FOR INTERAGENCY PERMITTING AND GENERAL ENVIRONMENTAL COMPLIANCE

District Manager recommended services from Karl Malamud-Roam, Principal at Vector Control Consultants, to assist with the Districts Source Reduction Permits and creating a White Paper on mosquito best management practices. Contract is for \$48,000 per fiscal year.
